3. Ongoing evaluation of impact

<u>Headline attainment figures</u> suggest that the majority of Catch-Up eligible students are on a 'Pathway' towards a 3 or above at GCSE, suggesting they can access the curriculum. There is an increase in the % of students making progress towards a 4 or above in Year 9, suggesting ongoing intervention is having an impact.

The exception is in Year 8 English. This is being addressed through intervention in the Accelerated Reader programme and more focused SEN support in groups with students with lower prior attainment.


<u>End of Year 7 Progress Reports</u> suggest that Catch-Up eligible students in 2015-16 made 'good' or 'excellent' progress in the vast majority of subject areas. This pattern was repeated with students, now in Year 9, who had been eligible for Catch Up funding in 2014-15.
