



Reading Scholars is a three year programme (start of year 10 to end of year 12), with two entry points. Participants can start the programme if they attend a participating school in Year 10, or as an individual (with the support of their school/college) in Year 12. Participants can choose to leave the programme prior to the beginning of the Year 12 programme. The below tables set out the criteria for participants to be eligible for a place on the programme:

| Participating schools should select ten students who are interested in participating in the programme and who meet the above criteria. The same ten students should attend all events. Schools will be required to provide details on the eligibility criteria the students they support to participate in the programme hit (anonymised), along with attainment data (anonymised) for these students at the beginning and at the end of the programme.
